- Physically, great core strength and hip flexor mobility.
   Emotionally, she feels proud and a sense of identity which has helped her confidence and social skills.
- My daughter has become more confident in herself, which is amazing. From her first day on Mac the mechanical horse she cried and was extremely nervous, then we got accepted into the 13-week block and my daughter loved every week.
- RDA helps tremendously with his mental health, learning about following instructions and accepting
  responsibility. It is hands on for both people and animals, sensory integration, and especially has
  improved his reflexes and motor planning which is one of the most needed for him.
- She has strengthened her core, she has gained confidence in her abilities, she has started to use and rely on the left-hand side of her body and further developed her empathy for animals. It has provided so much that we were unable to get for her from other therapies. It was a such a special time to be able to come to the RDA property and interact with the horses. Thank you.
- If I had to choose three words to describe it, I would choose calm, peaceful and fun. It's also tiring, but in a good way. We feel calmer when we get back, and that's why everyone wants to go to sleep.
- I learned how to keep calm, because horses are so sensitive, they can hear your heartbeat when you are close enough.
- Students gain self-esteem and self-confidence while learning how to work with such a large and powerful creature to achieve objectives. They also learn how to care for horses, which can improve responsibility and work ethic in their daily lives.
- Daphne, in partnership with Tall Timbers, has helped me achieve my goals of building my core strength and gross motor skills. But they have helped me with so much more. Every Saturday, the staff and volunteers greet me and wait patiently for a greeting in return. This builds my social skills which I can now apply to all aspects of my life. And another thing. I did not realise that Daphne would help me curb my anxieties. I feel calm when I'm riding her and after I ride her.
- Whatever volunteer work we all do, is for the benefit of the people who come and enjoy the rides and special training provided by RDA Tall Timbers.
- Volunteering has given me joy and purpose outside of family life. I am learning so much about the horses and how to handle and lead them, preparing the equipment for riding and the classes. I am learning how to engage and communicate with the children and celebrate their achievements.
- I feel that I have gained so much more personally out of my involvement with RDA, the riders, the horses and the volunteers than what I have contributed. Thank you.

#### **OFFICE ADMINISTRATOR'S REPORT - 2023**

RDA (NSW) Tall Timbers Centre provides various riding programs, life skills programs, Connections (Equine Facilitated Mental Health), groundwork programs, mechanical horse sessions as well as Speech Therapy. We are still on the lookout for an OT so that we can recommence the Occupational Therapy sessions.

The Centre would not be able to continue without the generous support of so many people, organisations and donors and we are very appreciative of their assistance. Fundraising continues to be challenging but it was wonderful to see that we still have many supporters who understand and appreciate the benefits of the services we deliver.



The Centre's recovery from the effects of the COVID pandemic continued in 2023. Volunteer numbers have improved but remain low. Unfortunately, our volunteer Coach numbers declined in 2023 for various reasons including personal relocation or employment changes but we have recently welcomed Janelle Patten who has joined the staff team as an experienced RDA Coach. This will enable the Centre expand our services and offer a consistent program each week.

The shortfall of funds required to run the programs and maintain the Centre come from fundraising, donations and grants. The Centre also holds term deposits which earn interest to help cover the operating costs of the Centre as well as allowing for property improvement and maintenance and for the purchase of necessary equipment. Tall Timbers Centre continues to subsidise the cost of our programs and the fees charged are only a portion of the cost for our Centre to offer a placement. We welcome any new and innovative ideas for helping us to raise funds to run the program and very much appreciate the efforts of those who run events on our behalf.

Due to the exorbitant cost of the Quality Audit required to remain an NDIS registered provider, the Committee and staff made the decision not to go through this process as it had become financially unviable with only a very small proportion of clients requesting claims through the NDIS Portal. However, our high-quality standards remain and this just means that participants now need to claim NDIS funds through a Plan Manager or the Self-Managed claim process.



Fortunately, Tall Timbers Centre was successful with applications for some grants throughout the year. We received \$25k through Perpetual Trustees. The Horse Shade area was refurbished with the assistance of \$20k from the Mitchell Stronger Community Grant and Community Building Partnerships supported the arena lighting upgrade and bird netting. We received \$14k through ClubsGRANT to assist with the cost of running the program. Hills Shire Council assisted with a \$10k grant for wages. The Association of Financial Advisers donated \$4k to the Centre. We received \$5k through the

Volunteer Grants Program to update equipment.

Thank you for the following major donations: The Profield Foundation for their continued support of the Centre. Bendigo Bank Foundation assisted with the cost of running the Tots/Tiny Tackers Program. Sutherland Shire Horse Owners donated \$5k in memory of Joy Charlton for riders working on independent riding and dressage training. BNI Sydney North West and Penrith \$6.5 as a result of the Charity Collective Golf Day. Mortgage Choice Charity Foundation donated \$4k for programs in 2024.

We continue to hold BBQs at Bunnings Rouse Hill throughout the year and sincerely thank them for allocating days to Tall Timbers Centre. In 2023 over \$10k was raised at the BBQs. We now offer cashless payments and this has also helped to increase the amount of funds raised.

Our team once again assisted with catering at the Model Railway Exhibition at Forestville hosted by the North Shore Railway Modellers Club who also donate a portion of the door takings to our Centre. Other fundraisers included a Horses' Birthday High Tea, catering for the Plant Collectors' Fair and Bingo. The Golf Day went ahead in March at the lovely Lynwood Country Club. We continue with Play for Purpose Raffles and are included in Return and Earn fundraising. We have also connected with Beyond Bank Community Rewards Program.

Our COVID safe plan continues to be in operation with organising systems, programs and training in place to keep the Centre running in a COVID safe manner. An online booking system remains in place for volunteers and participants. Administration continues to be done both on and off site.

We also love to be out and about in the Community. In 2023 we participated in the Orange Blossom Parade through Rouse Hill Town Centre, went in the Riverstone Festival Parade, attended Community Connect as well as the Christmas Market at the Galston Club and were most recently seen on Australia Day at Bella Vista Farm at the Hills Lions Clubs Fundraising Food Stall. Tall Timbers Centre was also a finalist for Outstanding Community Organisation at the Western Sydney Awards for Business Excellence.

As a celebration to finish off National Volunteer Week and to celebrate 50 years of RDA Tall Timbers we held a morning tea/reunion at the Centre. Guests received bookmarks and volunteers went into a draw to win some lovely prizes donated by Jim's Bookkeeping Baulkham Hills and GSR Plumbing.

Our Centre offers work experience and community work to students from universities and schools which they can do as part of their studies or Duke of Edinburgh Award Scheme. These students gain an understanding of our service and people with disabilities as they assist us in classes and with horse and rider preparation.



In December we held a combined Volunteer and Rider Awards morning tea at Tall Timbers Centre. Florian Wieser was presented with 2023 Volunteer of the Year – Florien has been assisting with property maintenance at Tall Timbers for over 10 years. Jared Guild and his mum Kate were jointly presented with Volunteer Achievement Award 2023. Lauren Downey was presented with the Young Volunteer of the Year award. Noah was awarded the Bill Harvey Memorial Award and Paige received the Rider Encouragement Award. Horse of the Year went to Nugget! Volunteer service awards were also presented. Major Awards went to Robyn Given for 40 years' service, Pip Lovely for 20 years, 15 years for Sophie Scarlett and Robyn Scott and 10 years awards went to Jen Walden, Rebecca Walden, Florian Wieser, Allan Gollan and Caroline Allen.

Thank you to the volunteers who help us to keep our grounds maintained and the gardens looking lovely. Thank you also to those Corporate Groups who undertook Working Bees throughout the year, your help is always appreciated. In 2023 we welcomed Lend Lease, Equifax and Zoetis. We also had a group from the Mitchell Youth Leadership Forum assist with weeding paddocks for a day.

#### COACH'S REPORT - 2023

As we reflect on 2023 it was clearly a year for consolidation but also presented opportunity and growth. Our newest normal following COVID gave us an insight into the current trends in the community and the impact of NDIS. We were able to assist 134 families in some way through the Equine program and another 60 through our Allied Health programs. We couldn't have done it without our Volunteers who support the Coaches through the sessions and behind the scenes.

Our School based programs have continued to struggle with enough staff to attend the Centre hence our Individual programs have continued to thrive. Making the programs available to Individuals not only helps fill the gaps between schools and groups but creates great opportunity for the families that are seeking opportunities for their loved one.



Thank you to the Community Building Partnership Grant program for supporting the arena bird netting and lighting upgrade. This has made a huge difference to the arena, it's amazing how many times we have used the lights in the middle of the day!



Our Coaches attended the RDA(NSW) State Coaching Workshop hosted by Ryde Centre in June. The focus of this workshop was the "Disciplines of RDA". Maddy was inspired to create entries for the Musical ride and within 8 weeks we had 2 entries submitted. Congratulations to the Saturday Participants and Volunteers for supporting Maddy. Their efforts received a 2<sup>nd</sup> and 3<sup>rd</sup> place!

Our Allied Health programs were presented to the RDA(NSW) Community at the 2023 Administration Workshop. While our Occupational Therapy programs are currently on hold, we continue to provide Speech Pathology services with a view to re commencing Occupational Therapy in the future. Thank you to Maddy for her commitment to the OT Role over the last few years and we wish her well in her future endeavours. Our Speech Pathologist, Allicia has continued to build a strong case load and forge relationships with many Pre-schools and Schools and North West Community Services to help assist the community with language and communication needs.

We again hosted Australian Catholic University Occupational Therapy students with the project aim to design a reference guide for RDA Coaches in relation to identifying a referral need to therapy programs.

We continued to support the community with Large animal rescue training in conjunction with David King – SES Hawkesbury. We held numerous SES Volunteer training sessions and 2 NSW Ambulance Rescue courses. Equine Pathways Australia clinics also continued with two more RDA participants taking up an opportunity to participate.

We were pleased to be able to attend Sydney International Equestrian Centre with Cody, Briar, Layla and Sarah riding Pablo and Bailey competing in the new format of the State Mounted Games event. We also provided support to Alicia a rider from Ryde Centre riding Pablo and Mikaela from Manning Great Lakes Centre to attend the State Dressage Championships.

We held a Mounted games event where many of our participants had the opportunity to participate in ridden or groundwork mounted games some for the first time! Congratulations everyone and thank you to the Volunteers that made this possible.

The end of the year saw us create more afterschool opportunities providing an introductory ground work program to participants on the waiting list. We acknowledge the contribution of our past Coaches who have not been able to coach for a variety of reasons since before COVID and know they are still around supporting the Centre. Thank you to Kirsty, Joan, Christie, Julie, Robyn, Katrina and Michelle; we know you are not very far away but we are also aware that we have to accept that Coaching regularly is not a possibility. Thank you for being part of our Golden Era, it has been an amazing contribution to the community.

Thank you to Kerry, Chanida, Sophie, Allicia and Maddy for supporting me and the day to day programs. It's a busy world we work in with ups and downs but at the end of the day we work to get it done for our participants.

Looking forward to seeing what 2024 brings our way!



#### 1 Statement of Significant Accounting Policies

These special purpose financial statements have been prepared in order to meet the requirements of the members and the financial reporting requirements of the Australian Charities and Not-for-profits Commission Act 2012 (and its regulations), and Charitable Fundraising Act 1991 (and its regulations).

The financial statements have been prepared on an accrual basis. Significant accounting policies adopted in the preparation of these financial statements are presented below and are consistent with prior reporting periods unless otherwise stated.

#### **Statement of Compliance**

The financial report has been prepared in accordance with the the Australian Charities and Not-for-profits Commission Act 2012 and the disclosure requirements of the following Australian Accounting Standards:

AASB 101: Presentation of Financial Statements

AASB 107: Statement of Cash Flows

AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors

AASB 1048: Interpretation of Standards
AASB 1054: Australian Additional Disclosures

No other applicable Accounting Standards, Australian Accounting Interpretations or other authoritative pronouncements of the Australian Accounting Standards Board have been applied.

#### a. Income Tax

No provision for income tax has been recognised as the entity is exempt from income tax under Division 50-5 of the Income Tax Assessment Act 1997.

#### b. Revenue recognition

Revenue is recognised when the amount of the revenue can be measured reliably, it is probable that economic benefits associated with the transaction will flow to the Association and specific criteria relating to the type of revenue as noted below, has been satisfied.

Revenue is measured at the fair value of the consideration received or receivable and is presented net of returns, discounts and rebates.

#### **Government Subsidies**

The Association recognises government subsidies when the right to receive the payment is established

#### **Government Funding**

Grants received are recognised according to the conditions of the funding agreement. Revenue from grants received is recognised when expenditure associated with the funding is incurred. The balance of unspent grant monies is shown as a liability.

#### **Donations**

Donations are recognised as revenue when received

#### Other Income

All other income is recognised as revenue when received

#### **Interest Revenue**

Interest income is mainly on interest-bearing cash and cash equivalent balances. Interest revenue is recognised on a proportional basis taking into account the interest rates applicable to the financial assets.

#### c. Goods and services tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or as part of the item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

#### d. Cash and cash equivalents

Cash and cash equivalents include cash on hand, deposits held at call with banks.

#### e. Investments

The financial assets disclosed as current assets represent investments with a maturity less than 12 months. All other investments with a maturity date greater than 12 months are classified as non-current.

#### f. Trade and other receivables

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### g. Prepayments

Prepayments are recognised on a proportional basis, where the goods or services are paid for the in the current year but are expended in future periods. Prepayments that are expected to be expended within a 12 month period have been classified as a current asset. All other prepayments (where applicable) have been classified as a non-current asset

#### h. Leasehold Property, plant and equipment

Each class of property, plant and equipment is carried at cost less, where applicable, any accumulated depreciation and impairment. The committee has determined for the 2023 year, as in the past not to depreciate the structures on site at this point. This policy will be reviewed yearly.

#### Depreciation

The depreciable amount of all fixed assets is depreciated on a diminishing value basis over their useful lives to the Association commencing from the time the asset is held ready for use.

The depreciation rates used for each class of depreciable assets are as follows:

An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

Gains and losses on disposals are determined by comparing proceeds with the carrying amount. These gains or losses are included in the statement of profit or loss and other comprehensive income.

#### Impairment of assets

At the end of each reporting period, the Committee reviews the carrying amounts of its tangible and intangible assets to determine whether there is any indication that those assets have been impaired. If such an indication exists, an impairment test is carried out on the asset by comparing the recoverable amount of the asset, being the higher of the asset's fair value less costs of disposal and value in use, to the asset's carrying amount. Any excess of the asset's carrying amount over its recoverable amount is recognised in the income and expenditure statement.

#### i. Trade and other payables

Trade and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the Association during the reporting period, which remain unpaid. The balance is recognised as a current liability. They are subject to normal credit terms and do not bear interest.

#### j. Employee entitlements

Provision is made for the Association's liability for employee benefits arising from services rendered by employees to the end of the reporting date. Employee entitlements that are expected to be settled within 12 months after the end of the annual reporting period are classified as current and have been measured at the amounts expected to be paid when the liability is settled, plus related on-costs. All other employee entitlements have been classified as non-current.

#### k. Accrued Expenses

Accrued expenses are recognised on a proportional basis (if applicable), where goods or services are incurred in the current year but are not invoiced until the following year. Accrued expenses that expect to be invoiced within 12 months of the reporting date have been classified as a current liability. All other accrued expenses (where applicable) have been classified as a non-current liability.

#### I. Inventory

Inventory is measured at the lower of cost and net realisable value. It does not include a value for the livestock on hand. Any costs associated with their purchase have been written off previously through the profit and loss statement.

#### m. Comparative figures

Comparative figures have been adjusted to conform to changes in presentation for the current financial year where required by accounting standards or a result of changes in accounting policy.

#### o. Additional company information

The Tall Timbers Centre, of Riding for the Disabled Association (RDA), operates an equestrian centre for persons with disabilities at Gables. RDA is a company limited by guarantee, and is the holder of an authority to fundraise, being the "umbrella" organisation for the Tall Timbers Centre, and similar centres throughout New South Wales. Tall Timbers acknowledges that RDA NSW is the trustee of all assets as recorded in the Financial Statements of Tall Timbers Centre as required for such entity.
